

Regulations of the WellU Gala Magic Moment contest

δ1.

General provisions

- **1.** These Terms and Conditions (the "Terms and Conditions") define the terms, conditions, and duration of the WellU Gala Magic Moment Contest (the "Contest") on Facebook.
- 2. The organizer of the contest is WellU Swiss Group GmbH with its registered office at Schulstrasse 14, 9450 Altstätten, Switzerland, registered with the Handelsregister des Kanton ST. Gallen CHE-407.196.596, which entrusts the execution, conduct and operation of the contest to WellU Sp. z o.o., headquartered in Gdynia, 280 Wielkopolska Street, 81-531 Gdynia, registered in the National Court Register, maintained by the District Court Gdańsk- North VIII KRS Department, under the KRS number 0000354591, NIP number: 586-225-16-36, hereinafter referred to as "Host" or "WellU"
- **3.** The contest is conducted on the Host's social network: https://www.facebook.com/wellubusinessgroup/

§ 2.

Duration of the Competition

The contest is conducted on the territory of the Republic of Poland and lasts from 07.02.2024 to 12.02.2024.

§ 3.

Competitors

- **1.** The Contest is open to a Participant who is a natural person and who meets all of the following conditions:
 - a. Has full legal capacity,
 - **b.** Has a public Facebook account,
 - c. follow WellU's Facebook account,
 - **d.** correctly completes the competition task.
- **2.** Employees and associates of the Organizer and the Contest Host, as well as members of their immediate families, may not participate in the Contest.
- **3.** Participation in the Contest is free of charge.
- **4.** Before participating in the Contest, the Participant should read the Regulations. The Organizer and Host states that the text of these Regulations is available at www.wellu.eu. Taking part in the Contest understood as the execution of the task by the Participant will be tantamount to:
 - a. familiarization with and acceptance of the Regulations,
 - **b.** consent to the processing of personal data solely for the purpose of this Contest and the distribution of Prizes in accordance with § 7 of the Regulations,
 - **c.** consenting to the posting of his/her name and user name in the event that he/she is awarded the Prize.







- **5.** The Organizer and the Host of the Contest are not responsible for the content of the application and the content of the materials posted by Participants on the Facebook profile.
- **6.** The Organizer and the Contest Host shall not be responsible or party to any disputes regarding Participants' rights to Facebook Accounts. Any disputes regarding the aforementioned rights do not affect the principle that the person entitled to receive the prize is the person whose data will be provided to the Organizer in accordance with the Regulations.
- **7.** The Organizer and the Host inform that the Contest is in no way sponsored, endorsed, administered or affiliated with Facebook. The information provided by the Entrant is the information provided to the Organizer and Host, not Facebook, and will be used solely for the purpose of conducting the Contest.

§ 4.

Competition Rules

- **1.** The Participant's task is:
 - **a.** writing on the official profile of the Organizer, under the post informing about the contest, a comment developing the sentence "this moment from the Gala will stay with me forever".
- **2.** The contest is won by the person whose comment collects the most likes, left by portal users during the contest period.
- **3.** Upon completion of the Contest Task, the copyright to its free use in all known fields of exploitation, in particular those listed in Article 50 of the Law on Copyright and Related Rights, is transferred to the Organizer and the Host free of charge.
- **4.** The Participant of the Contest declares that the ideas submitted to the Contest are his/her own and do not violate any rights of third parties. The Participant bears the responsibility for this.
- **5.** It is forbidden to use fictitious Facebook profiles for competition purposes.
- **6.** The Organizer and the Host reserve the right to remove from the Contest selected Participants for whom there are reasonable suspicions that they or persons acting in their interest have set up fictitious Facebook profiles and used them for fraudulent participation in the Contest.
- **7.** It is the duty of the Organizer and the Host to inform the Contest Participant of his/her removal from the Contest with the reason. Such information will be provided using private messages via Facebook.

§ 5.

Winners and prizes.

- **1.** The prize in the Contest is a surprise prize, selected from the assortment produced by the Organizer, with a value of €150.
- 2. The winner of the Contest will be announced on the WellU profile within a week after the end of the Contest. He/she will be informed by the Conductor about the Prize on the Facebook profile. The Host will ship at his own expense by courier package.









- 3. When the Host is unable to contact the Winner of the Contest for any reason or does not promptly receive a response to the sent notification of winning, the Host reserves the right to award the Prize to another Participant. The Winner is obliged to provide personal and address information.
- 4. In the event of cancellation of the Prize by the Contest Winner, the Host will not be obliged to transfer the Prize.
- 5. The Host reserves the right to verify the Contest Winner's account for compliance of the Participant's conduct with the provisions of these Regulations. If he/she is disqualified by the Conductor, then he/she shall forfeit the right to the Prize and the Prize shall not be released and shall remain the property of the Conductor.
- **6.** The prize is not convertible into equivalent cash or other material prize.
- 7. The winner of the Contest acknowledges that receipt of the prize constitutes income for him/her under the tax laws and is subject to income tax.

§ 6. **Complaints**

- 1. Complaints regarding this Contest may be sent in writing to the Moderator's address: 280 Wielkopolska Street, 81-531 Gdynia, no later than 14 days from the date of the event giving rise to the complaint.
- 2. Complaints delivered after the deadline specified in paragraph 1 will not be considered.
- 3. Decisions on filed complaints are made by the Presiding Officer.
- 4. The participant filing a complaint is informed of the outcome of the complaint procedure in writing or by e-mail.

§ 7. **Personal Information**

- 1. Processing of Participants' personal data will be carried out in accordance with the rules provided for in the Act of August 29, 1997 on the Protection of Personal Data (Journal of Laws of 2002, No. 101, item 926, as amended).
- 2. The Contest Administrator will be the administrator of personal data provided by Contest Participants. Personal data will be processed only for purposes related to the subject matter of the Contest, i.e. for purposes related to the organization and conduct of the Contest.
- 3. Providing personal data is voluntary, but it is necessary to participate in the Contest. Persons providing personal data have the right to request correction and to demand deletion.
- **4.** Personal data of Participants after the end of the Contest will be deleted.

ξ8. **Final provisions**

- **1.** The Regulations are the only document that defines the rules of the Competition.
- 2. The Organizer is not responsible for any technical problems not on the Organizer's side.

- **3.** All information about the Contest contained in any promotional and advertising materials is only of an auxiliary nature, while the scope of rights of the Participants and the Organizer is regulated and evaluated on the basis of the provisions of these Regulations.
- **4.** The Organizer reserves the right to change the Regulations, if this will not impair the conditions of participation in the Contest.
- **5.** Both Participants and the Organizer will strive to resolve any disputes arising under the Terms and Conditions in an amicable manner, through negotiation.
- **6.** In no case shall the Organizer's liability to the Participant exceed the value and number of Prizes specified in these Regulations. The limitation of liability referred to in the preceding sentence shall not apply if such limitation of liability is in conflict with applicable law.
